- 1. On 13 December 2024 the Claimant issued a claim against the Defendants in Schedule 1 and Persons Unknown (as defined fully in the Claim Form) and an application seeking interim precautionary injunctive relief.
- 2. The injunction order sought includes prohibitions in relation to:
 - a. The "Shipley Site", which means Teledyne UK Limited's site at Teledyne UK Limited, Airedale House, Acorn Park, Shipley BD17 7SW (specifically, prohibitions on trespass and interference with the Claimant's common law right to access the highway); and
 - b. The road known as Acorn Park, Shipley (specifically, prohibitions on obstruction of the highway).

26 December 2023 Incident

- 3. On 26 December 2023 (Boxing Day), at approximately 4.30am, one individual gained access to the Shipley Site by climbing over the fence. They then approached the building and attempted to set fire to a goods entrance.
- 4. The individual was arrested by police officers acting for and on behalf of the Respondent and were subsequently released on bail.
- 5. The Claimant suffered loss, by way of repair bills and loss of production revenue, in the amount of approximately £35,000.

2 April 2024 Incident

- 6. On 2 April 2024, at approximately 5.30am, a group of around 20 protestors attended the Shipley Site. Four of these protestors managed to climb on to the roof of the premises and proceeded to cause extensive damage to the roof tiles and brickwork, as well as the glass doors and windows these four protestors were arrested by police officers acting for and on behalf of the Respondent and were subsequently released on bail.
- 7. The Claimant suffered loss, by way of repair bills and loss of production revenue, in the amount of approximately £871,000.

15 May 2024 Incident

- 8. On 15 May 2024, at approximately 4.30am, four individuals gained access to the roof at the Shipley Site and once again caused damage to the roof. They were arrested by police officers acting for and on behalf of the Respondent and were subsequently released on bail.
- 9. The Claimant suffered loss, by way of repair bills and loss of production revenue, in the amount of approximately £128,000.

Persons Known

- 10. The Claimant is aware of the identities of the persons arrested on 2 April and 15 May 2024, and has named them as the First to Seventh Defendants (inclusive) to injunction proceedings; the Claimant is however not aware of the contact details of those persons arrested in the above incidents. It is the Claimant's position that the identities and contact details of those persons arrested are known to the Respondent.
- 11. The Claimant's position is that the persons arrested ought to be named and served in these injunction proceedings in order to be subject to the jurisdiction of the Court and any injunction order made. The

Claimant therefore requests disclosure of relevant documents in order to confirm the identities of (and assist with effecting service on) the individuals who have previously trespassed onto its property and been arrested by the Respondent.

- 12. Disclosure of the classes of documents requested will enable the Claimant to:
 - a. add all those individuals that it alleges to have committed trespass in the past to the Claim as named individuals (and confirm the identities of those persons already added);
 - b. effect service of documents on those individuals in the proceedings; and
 - c. commence any further necessary proceedings against those individuals should they breach any injunction order in the future.
- 13. In conclusion, I believe that the Respondent holds the classes of documents requested in the Draft Order, that those documents will support the Claimant's case or adversely affect the case of the Defendants and will assist the court to dispose fairly of the action or save costs.
- 14. I believe that it is appropriate for the court to exercise its power under CPR 31.17 to make the Order requested for those reasons.
- 15. The Respondent has confirmed by way of the witness statement of Stephen William Simpson dated 16 December 2024 (attached to this Application Notice) that he adopts a neutral position on the Application. The Draft Order has been produced jointly with the Respondent.
